The seller hereby sells to the Buyer, for the amount of \$_____ payment of which is hereby acknowledged, a Field Bred English Springer Spaniel puppy, born _____, out of _____ & _____, in accordance with the terms of this contract.

Initial Conditions: The breeder guarantees that the puppy is in good health on the date of delivery. The Buyer has the right to return the puppy to the Breeder within three days after delivery and receive a refund of the purchase price if the puppy is found by a veterinarian to be suffering from any disease. Breeder guarantees that puppy will be sold with the following: Record booklet of all vaccinations, de-worming, AKC registration papers, and this purchase agreement/warranty.

Buyer Responsibilities: With this purchase, buyer agrees to these conditions and limited guarantees***Buyer pays all crates, flight physical and shipping costs. The Buyer shall maintain the puppy in good condition, including adherence to a regular immunization schedule, heartworm preventative, good diet, and a clean and safe environment.

Buyer has been informed of various puppy diseases and agrees to avoid frequently traveled places before this puppy has been fully vaccinated.

Buyer agrees to provide essential crate training and basic obedience training with moderate exercise for the first year of the dog's life. Buyer has been informed that growth plates in puppies begin closing between the ages of 9-15 months old and avid hunting or other recreational sports requiring sustained running and jumping is not recommended on puppies under a year old in order to give bones and joints time to finish growing.

Buyer agrees they will not surrender this dog to any animal shelter or

Springer rescue group. If at any time in its life this dog must be re-homed or relocated, and for any reason, Buyer will return this dog back to Breeder at the buyer's expense. Buyer will maintain this warranty for their records.

Buyer's failure to honor this contract and at the expense of the dog's physical well being, or through neglect or abuse, will result in a civil dispute and reclamation of the dog.

The buyer shall not sell the puppy, or its offspring (if any), to any individual or establishment in the business or buying and selling puppies for a profit.

Our Guarantee: We guarantee that our breeding dogs have normal hip radiographs certified through the OFA/PennHIP.

Our Warranty: The warranty for the above dog is valid to the original owner only. Should this dog during the first twenty four (24) months of its life, be diagnosed with a disabling genetic disease rendering it unfit for hunting, Breeder agrees to replace the dog with another of equal purchase value or refund the original purchase price. Breeder must be notified in writing with an ACVO/CERF or OFA DVM diagnosis. In some cases, the Dog must returned to Breeder for a 2nd Opinion Examination, then it will be returned to owner. If an abnormality is found a refund will be made after the dog has been neutered/spayed.

NOTE: The genetic health and temperament of your puppy is extremely important to our breeding program and we greatly value your feedback. If at any time during its life, this dog develops a health or temperament disorder of any kind, we want to hear about it!

Registration: This puppy is to be registered with an American Kennel Club (AKC). NO OTHER KENNEL CLUB REGISTRY will be approved, honored or endorsed under our kennel's warranty.

No Financial Responsibility: Other than the above limited warranty, Breeder assumes no financial responsibility or other liability for this dog after it leaves premises.

A \$300. Non-Refundable Deposit is required to reserve a puppy; the buyer has 24 hours to cancel the deposit once received by Breeder.
